### Payment Terms / Cancellations

An invoice will be sent for payment, which will be **due within 15 business days of receipt of the invoice**. All exhibit/sponsorships must be paid IN FULL by **March 3, 2025**. If payment isn't received by the due date, the exhibit/sponsorships may be given to another exhibitor at the discretion of NANS. No exhibit/sponsorship opportunity can be held until a signed application/contract is received.

Should an exhibitor cancel an exhibit/sponsorship for any reason, it should notify NANS in writing and pay NANS the applicable cancellation fee listed below.

## TERMS & CONDITIONS

- 1. Application and Eligibility.** Application must be submitted using the above form, contain the information as requested, and be executed by an individual who has authority to act for the applicant. Exhibit/sponsorships are an opportunity for companies to advertise products and services relating to the practice and advancement of the art and science of neuromodulation and the professional education of those individuals attending the meeting.
- 2. Assignment.** Exhibit/sponsorships will be confirmed based upon the order in which the requests are received.
- 3. Payment/Guarantee.** No exhibit/sponsorships can be held until a signed application/contract is received. No exhibit/sponsorship will be confirmed until a signed contract is received, and an invoice has been sent for payment. No exhibit/sponsorships are guaranteed until NANS receives full payment of the total fees due. If payment isn't received by the invoice due date, the exhibit/sponsorships may be given to another exhibitor at the discretion of NANS.
- 4. Cancellation.** If the company notifies NANS of their intent to cancel an exhibit/sponsorship, on or before March 3, 2025, a refund of 50% of the monies received will be issued per item. No refunds will be made, or cancellations accepted after March 3, 2025.
- 5. Deadlines.** Companies must meet the deadlines set by NANS for artwork, email content, etc. or risk the possibility of forfeiting the exhibit/sponsorship; NANS will not refund any monies in these cases. If a company submits artwork, email content, etc. past the deadline it will be subject to a \$500 late fee per item.
- 6. Formats.** Companies must submit content in the format NANS requires. If it is not submitted in the format required then it will be returned until the correct format is received, which may cause delays. Any content requiring reformatting/manipulation by NANS on the company's behalf will incur a minimum fee of \$500, with final cost to be determined by the scope of the work.
- 7. Additional Fees.** NANS will do its best to offer opportunities that are turnkey and not subject to additional fees, however there may be cases when additional charges may be applicable, and NANS will notify companies of these as soon as it is made aware of them.
- 8. Approval.** All advertisements are subject to approval by NANS. NANS reserves the right to revise any aspect of any of the exhibit/sponsorships to preserve the integrity and professional atmosphere of the meeting.
